1. Outline progress over the last 6 months (April – September) against the agreed project implementation timetable (if your project started less than 6 months ago, please report on the period since start up to end of September).

The project has made significant progress since its inception, with several key activities completed and ongoing. We have successfully conducted the project inception phase, including a project presentation and focus group discussions (FGDs) with partners, stakeholders, and representatives from barangays in potential sites along the Pared River Catchment. A Project Technical Working Group (PTWG) has been established, bringing together key local representatives, including the legislative members of local government units (LGUs), Councillor Committee Chair on Environment and Natural Resources, Councillor Chair for Agriculture and Fisheries, Municipal Environment and Natural Resources Officer (MENRO), Municipal Agriculturist (MA), Tourism Officers from the three municipalities involved, the Freshwater Sanctuary Manager of Baggao, as well as officials from the Bureau of Fisheries and Aquatic Resources (BFAR) and the Department of Environment and Natural Resources (DENR-CENRO). Additionally, the biological assessment of the Pared River Catchment has been completed, along with land use mapping and an inventory of invasive flora and fauna in the area. As included in the target activities of the project, strengthening the management board of the existing sanctuaries within the PRC initiated, through conducting a Freshwater Sanctuary Management Board (FSMB) meeting, with a focus on presenting the new project, reviewing the roles and responsibilities of FSMB members, and addressing important matters such as

amending the FS Municipal Ordinance to expand the protected areas, updating the FS management plan, re-installing markers and signages, monitoring activities by the CMG/River wardens, and discussing incentives for the wardens. In terms of site identification, ten potential locations for establishing new FS have been identified within the Pared River Catchment and its tributaries, covering an estimated area of 175 hectares. Regarding invasive species, three invasive flora species—*Gmelina arborea* (G-Melina), *Leucaena leucocephala* (Ipil-ipil), and *Swietenia macrophylla* (Mahogany)—were identified along the catchment, with a total count of 5,246 trees. An application for a Cutting Permit has been submitted to DENR's Regional Director for approval, and the inventory report for invasive flora species has been prepared. 54 native tree species and 59 bird species have been recorded and identified in the project area. In collaboration with the LGU of Baggao, the project team also co-facilitated a refresher course for river wardens on law enforcement to strengthen the protection of the Pared River.

The availability of a functioning drone has impacted the approach and timing of our land use mapping activity, shifting it to Q3Y1. Initially, land use mapping was conducted using the base map available in Barangays along the PRC, which was then validated on the ground by the team. Participatory\_land use planning and mapping are now scheduled for Q3, contingent on the DENR drone's repair, which has now been completed.

The recruitment of the full project team has taken longer than anticipated, due to sourcing qualified candidates and the need to align recruitment efforts with the specific skill sets required for the project. This has led to an underspend in the budget allocated for salaries. To address this issue, we are exploring the possibility of requesting to carry over the allocated funds into an additional financial year (FY4) to ensure that the project can be properly resourced and implemented as intended. We plan to submit a formal financial change request in due course to seek approval for this adjustment.

The continued commitment of LGU Baggao to strengthen and institutionalize their river wardens/Community Management Groups (CMGs) and the Freshwater Sanctuary Management Board (FSMB), with support from BFAR, has been a vital step toward sustainable freshwater sanctuary management. Recently, LGU Baggao conducted a refresher course on law enforcement for the river wardens and established a consistent incentive system for them through the Municipal Ecotourism Office's regular fund. As we look toward the project's exit, we will consider these achievements to ensure the legacy and lasting impact of effective freshwater sanctuary stewardship. Additionally, BFAR has extended its efforts to establish FS in other areas. There has been a request for ZSL and BFAR to assist in site assessments for proposed locations, and ZSL is expected to participate soon. ZSL will also support the development of management plans for these new sites.

To ensure a coherent network, site selection and prioritization are being guided by assessments and led by local communities to align with local priorities and needs. We have further refined our Pathway to Change and will share details in the annual report. Livelihood diversification is guided by our project team's technical expertise to ensure options are both climate-resilient and sustainable, meeting community needs. DENR remains an active project partner under an MoU which is currently in development, and we are collaborating closely on river basin and catchment approaches.

Additionally, to address watershed protection concerns, we are implementing ZSL's FAIRER approach, including grievance mechanisms to safeguard community rights and mitigate risks associated with land and water use conflicts.
