1. Outline progress over the last 6 months (April – September) against the agreed project implementation timetable (if your project started less than 6 months ago, please report on the period since start up to end of September).

During the past 6 months, all 7 partner villages in Kubu Raya have completed the 7 stages of Natural developing the Adaptive Resource Management Plan (ANRMP): 1) resources/ecosystem mapping; 2) policies and regulation identification; 3) challenges identification; 4) identifying selected resources/key species threshold indicators; 5) planning the management strategies; 6) monitoring and surveillance and 7) law enforcement. The next step is to organise a public consultation and feedback session with the communities in each village. So far this has only been conducted in Dabong village for the three commodities mudcrab, fish and shrimp. In October, the people in Dabong will have an additional consultation on coconut. For the other 6 villages, the feedback session has not yet been conducted and is scheduled for November and December 2024. The natural resources managed by the communities include non-timber forest products and resources or commodities that are familiar for the farmers such as coconut, betel nut, and rice. Additionally, the fishers planned to manage the key species commonly harvested such as mudcrab, shrimp, and fish, as well as chicken husbandry. The selected species of each village are:

- 1. Dabong : crabs, fishes, shrimps, coconut
- 2. Tanjung Harapan : crabs, rice, shrimps
- 3. Mengkalang : coconut, rice, betel nut
- 4. Mengkalang Jambu : chicken, rice
- 5. Seruat Dua : coconut, rice, betel nut
- 6. Sungai Nibung : crab, fish, shrimp, rice
- 7. Kuala Karang : shrimp, fish, crab

In the process of developing the ANRMPs, 17 local village governance bodies participated, consisting of 6 LPHD (Village Forest Management Institution) and 11 Conservation Cooperative (CC). Another community local stakeholder involved is *Karang Taruna*, the social youth organisation, which focuses on fostering and developing opportunities for the younger generation and the Village-owned Enterprise (BUMDes).

The established multi-village forum called "Forum 7" focused on the development of its organisational management capacity, specifically the neccesary tools and guidance. 8 members as representatives of the 7 villages were trained on the preparation and development of statutes and annual work plans, administrative and financial management, as well as practising the concept of 'radical listening'. In addition to internal capacity-building training, Forum 7 convened a public audience with the Regional Development Planning, Research, and Development Agency (Bappeda Litbang) of Kubu Raya Regency to deliberate on its organisational legal status. As a result, Bappeda Litbang recommended that Forum 7 be developed into an Inter-Village Cooperation Agency (Badan Kerjasama Antar Desa-BKAD), as this legal status would potentially enhance opportunities for securing government support for various initiatives.

Specific capacity building training of monitoring and data collection for the "Forum 7" community stakeholders has not yet occurred. We have signed the MoU with the Provincial Marine and Fishery Office (DKP) to build the capacity of the members of Pokmaswas (Community Surveillance Group) established by DKP for the monitoring and data collection training.

During this reporting period, several opportunities for growth and improvement emerged. These included the need for clearer role divisions between YPI and Forum 7. Due to the older age of most of the Forum 7's management members, training and capacity building techniques need to adapt to existing skill sets so that the benefits of these knowledge exchanges are maximised. We also face the challenge of optimising time management with all individuals having busy schedules.

During the feedback session held in Dabong Village, the local community suggested implementing patrols in the village forest area to safeguard the sustainability of aquatic species,

including crabs. In fact, this is a challenge for YPI, as there is currently no formal collaboration between YPI and the LPHD of Dabong as the local authority responsible for the surveillance and protection of the village forest area.

We also learned that the recommendation from Bappeda Litbang-Kubu Raya Regency to form a legal identity of Forum 7 as recognised Inter-Village Cooperation Agency (BKAD) could open up opportunities for adaptive natural resource management in the future.
