The project has progressed well in our assessment.

An online survey was conducted inviting conservation practitioners interested in becoming PARTNERS principles trainers through the SLT-managed Ethical Conservation of Alliance, the Snow Leopard Network, and through some of our conservation partners such as the Whitley Fund for Nature early in the year. As a brief reminder, the PARTNERS principles, are a set of principles and guidelines for ethical and effective community-engagement in conservation, developed based on the extensive experience of the Snow Leopard Trust partner network, and with inputs from senior conservation practitioners around the world. They comprise a set of eight key principles described by the acronym PARTNERS. Nine individuals (4 men and 5 women) were selected to be trained as trainers in Issyk-Kul, Kyrgyzstan from September 12-15, 2024. This training was also attended by the UK Ambassador to Kyrgyzstan, Excellency Nicholas Bowler who presented participants with certificates of completion at the end of the workshop. Trainees were from India, Uzbekistan, Bhutan, Mongolia, Kyrgyzstan, UK and

| Indonesia. The trainees included two of our new Scientists who have joined our team recently, attend the trainings. The next trainings are expected to held in Mongolia in February 2025 and in Nepal in March 2025. The participation of one trainee each from Indonesia and Mongolia was supported financially by the Whitley Fund for Nature. | | | |
