### Securing Rights through Social Forestry Scheme

During this period, no new social forestry permits were issued. However, we maintained the existing 13,469 hectares secured in Year 1 by facilitating the establishment of 3 Village Forest Management Institutions (LPHD) in 3 villages. Support was provided to these LPHDs in designing their organisational Articles of Association and bylaws, as well as support in preparing their Annual Work Plans. Additionally, three potential areas in two villages in West Kalimantan are currently proposing additional 6,533 hectares. The villages have completed the technical field verification. In addition to securing management rights in general, we particularly support women in accessing and using resources in tenurial areas; in Bengkulu, we continued to establish and support 4 additional groups of women.

## Adaptive Resources Management Plans

In Y1, 8 adaptive resource management plans were developed in our coastal-mangrove forest and terrestrial areas, and these existing plans are now in the process of sharing sessions with local stakeholders to get feedback before the implementation. During this reporting period, 1 additional adaptive resources management plan was developed in Bengkulu.

#### SMART Patrols

Between April-September 2024, 30% of the total area was patrolled (433,019.29) by the 16 existing community-led SMART patrol teams in West Kalimantan. Two (2) additional teams were established in Bengkulu that will contribute to the larger coverage of the patrolled area.

#### Governance Bodies

During this reporting period, 11 governance institutions in Bengkulu with 454 direct beneficiaries were added to the existing 61 governance institutions with a total of 4,401 direct beneficiaries supported.

# Livelihood Support

The value of assets accrued by the project's savings and loans program increased by 5.19% in this reporting period. We calculated the growth rate of the assets by taking the value of total assets up to March 2024 (IDR 3,963,413,195.78) and compared it to the total value of assets accrued until August 2024 (IDR 4,169,225,383). Additionally, we calculated the loan repayment after the savings/loans programme has been running for one fiscal year, and we have observed 78% of loan repayment rate from members who have accessed loans. During project support, 39 or 5% governance bodies already operated their program activities in savings/loans, farming, health, fisheries, and livelihoods.

### Climate Smart Agriculture and Sustainable Fisheries

During this reporting period, 826 farmers participated in project facilitated training on using semi-organic herbicides, grafting trees for agroforestry programs, producing biochar, and legume cover crops to improve yields through climate friendly practices. 13 new income generating opportunities are supported in West Kalimantan, for example, animal husbandry (broiler chicken and goat farming) and agriculture (corn and vegetables farming, agricultural product processing or agribusiness). In fisheries, we have supported 533 fishers through improved fisheries management in our coastal and marine areas of West Kalimantan during the reporting period.

# Healthy Family Initiatives

We have trained and supported a total of 91 health ambassadors during April-September 2024, with 3,274 individuals reached during visits to assist families with public health education and services. The basic and mandatory topic to be delivered is "12 Indicators of a Healthy Family." The Health Ambassadors, together with the respective local government health clinics (PUSKESMAS) have organised 37 travelling clinics to enable local communities to access free health services. This involved the visits of health workers such as nurses, midwives and doctors.

Indigenous communities we partner with show a strong interest and willingness to pursue the Customary Forest (Hutan Adat) scheme. However, the permit approval process tends to be lengthy, particularly in areas within the regency with an absence of Indigenous Peoples recognition in the form of local district regulations as the prerequisite to apply for the permit. Additionally, the government's target for the designated area of Customary Forest in West Kalimantan has been surpassed and is no longer a priority. Also, changes in the ruling government (the new president and ministers) are usually followed by frequent regulatory and policy shifts, which will likely affect the process of establishing and approving community-based management plans through the Social Forestry Schemes. These challenges necessitate YPI to develop adaptive strategies and approaches tailored to the local communities. Also, YPI has been actively coordinating and consulting with BPSKL (The Social Forestry and Environmental Partnership Agency) to adapt with the updated Social Forestry policies and issues, and will also need to adjust with the new relevant government body formed by the new ruling regime.

The Healthy Family Initiatives program for the travelling clinic often faces medical shortages at local clinics, affecting follow-up care. To address this, Health Ambassadors identify prevalent diseases beforehand and report them to government clinics to ensure sufficient medication.
