1. Outline progress over the last 6 months (April – September) against the agreed project implementation timetable (if your project started less than 6 months ago, please report on the period since start up to end of September).

The project is progressing in line with the work plan, and the main activities by output implemented during the first semester are shown below:

- Output 1:

1.1. The Seed/seedling Suppliers Consultation Group (SSCG), including Government, NGOs/CBOs and private sector suppliers has been established. Terms of refence for the SSCG have been agreed and shared to all members. The SSCG has around 30 members, from Tanzania Forest Service, Zanzibar Forest Department, Tree Seed Centres, Research Institute, Botanic Gardens, Academic Institutions, and NGOs working on biodiversity conservation and tree planting projects. The first SSCG meeting was held online the 12th of July 2024, with the participation of 23 members, discussing: project overview, role of SSCG, resource gap analysis and species prioritisation and conservation action planning.

1.2. A consultation across sectors to identify the main policy and practical constraints to collecting, storing, growing and supplying NTS is ongoing.

1.3. A first baseline survey of technical capacity and availability of NTS seeds/seedlings across the project partners is also being carried out and it will be extended to Government, NGOs/CBOs and private sector suppliers.

1.4 The species prioritisation rationale has been developed and shared to the SSCG. A comprehensive set of selection criteria has been developed to enable the prioritization of the 100 useful and ecologically important NTS to be targeted by the project. The same criteria will also be used to identify the 30 NTS for development of propagation protocols. A survey data sheet has been developed to collect information on the potential species across Tanzania that will be administered by the project partners and members of the SSCG. A workshop to finalise the species selection is planned for February 2025.

- Output 2:

2.2 We have started collating information, data tools and resources that are already existing for Tanzania, that will be added into the NTS web platform, planned to be created by the project. The members of the SSCG are also starting to contribute to these resources and identifying gaps in resources that can be filled by the project and uploaded on to the web-based hub.

2.3 We have developed terms of reference for the development of seed zone and potential vegetation maps for at least 100 useful and ecologically important NTS. The process of selecting the right service provider to aid in the development of the maps is currently underway.

2.4 The process of prioritizing the 30 NTS for development of seed storage, germination and propagation protocols has already started and more activities will continue in the next semester.

- Output 3:

3.1. Technical capacity needs assessment for Tanzania on NTS conservation was conducted through the project partners and SSCG members. We received good results and indication of where knowledge gaps are, especially regarding the propagation of individual NTS. This has informed the development of the content for the ToT trainings, aimed at filling all the gaps identified to enable a more diverse NTS portfolio for Tanzania. The ToT training on seed collection, processing and storage will be held from the 8th to 10th of October in Arusha. Around 35 trainers have been selected from NTSC and NGOs/CBOs.

- Output 4:

Activities will start in the next quarter and will continue in Y2.

2. Give details of any notable problems or unexpected developments/lessons learnt that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

Due to the extensive process and departments involved in getting grant agreements reviewed and signed by Tanzania Forest Service, we encountered some delays in the first half of the project. However, by the end of September, the agreement was nearly completed. TFS was able to participate in the above-mentioned activities since any financial implications were needed to be covered by funds allocated to the lead partner. This helped in ensuring there were no great delays in activities implementation. We are currently discussing with TFS their ability to complete all scheduled activities for Y1. At present there is no indication that there will be any significant impact on the budget or timetable. Should our assessment reveal any risk in this regard, we will submit a change request before the end of the year.
