Darwin Plus Project Information

1. **Project summary**

The project aims to protect East Caicos, at 47 square kilometres, the largest uninhabited island in the Caribbean UKOTs, from unplanned and unrestrained development through giving a voice to local communities who have used and continue to use the island, and to stimulate new nature-based uses.

The project aims to "change the narrative" around East Caicos from that of it being an undeveloped island awaiting development, to that of it being an amazing nature-based resource that offers economic opportunities to the country and its people.

It will achieve this through awareness raising, and involvement through community and stakeholder workshops leading to the development of a Community Conservation Area registered with IUCN (International Union for the Conservation of Nature) and represented by a committee or council drawn from the local communities and supported by the local National Trust.

This is important as whilst some 45% of the land area of TCI is designated "Protected Area" these designations have, to date, been largely imposed from outside the communities that they primarily affect and lack legitimacy. The aim of this project is to achieve legitimacy through the most affected communities having the leading voice in however East Caicos is preserved and managed into the future.

2. Project stakeholders/partners

Royal Society for the Protection of Birds (RSPB)

The lead partner is RSPB which has been working with the OTs for over 25 years. The underlying principle of our work is to establish enduring relationships with local partners to help support the development of sustainable and locally-lead conservation programmes. RSPB is established in the Turks and Caicos Islands. A successful EU BEST II project followed by two Darwin projects (DPLUS055 and DPLUS121) have given RSPB a long-term presence and deepened our relationship with local actors.

The formal partners working alongside RSPB are:

The Turks & Caicos National Trust (TCNT)

The Turks and Caicos National Trust is the local membership-based, non-profit organization dedicated to the preservation of the natural, historical and cultural heritage of the Turks and Caicos Islands. The Trust has earned the trust of the citizens of the TCI since its creation in 1992.

TCNT is responsible for leading on the engagement and facilitation of North, Middle and South Caicos community members in the conservation planning process, particularly through the Community Workshops and raising awareness of the potential for East Caicos both to be a repository of TCI's rich heritage and culture AND contribute to its sustainable economic development.

Marine Conservation Society (MCS)

MCS has been active in the Caribbean UK Overseas territories for over 20 years and provided significant support to partners to improve management of their Marine Protected Areas. MCS has worked on partnership projects in the Turks and Caicos Islands (TCI) alongside the Government's Department of Environment and Coastal Resources (DECR) since 2002.

MCS is responsible for leading the use of the Community Voice Method (CVM) including participant filming, footage transcription and data analysis, film editing and screening of the CVM and leading efforts to better understand the importance of East Caicos for turtles.

Others

In addition, three regional and TCI subcontractors have been engaged and contracted by RSPB to support project activities. These are,

- **BirdsCaribbean** who have lead bird guide training workshops and engaging hoteliers to raise awareness about nature-based tourism opportunities.
- SWA Environmental –who will support TCNT and community members participation in bird/plant survey techniques and update/establish estimates of IBA trigger species and presence/absence of non-native species.
- Turks & Caicos Reef Fund (TCRF) who have through field work and survey, established the extent of Stony Coral Loss Disease (SCTLD) on coral reefs off East Caicos thanks to the baseline collected through an EU BEST grant in 2018. TCRF was able to collect comprehensive baseline data on benthic cover and fish biomass, a data set is now more important than ever as SCTLD arrived in the Turks and Caicos in 2019. In 2021 and 2023 TCRF revisited those sites, and the data are still being analysed.

In this reporting period all contracts and partnership agreements have been completed and both BirdsCaribbean and Turks and Caicos Reef Fund (TCRF) have now completed their work programs within the project.

The three main partners (RSPB, TCNT and MCS) meet regularly at several levels (from leadership through to project delivery teams) and established a superb working relationship.

3. Project progress

3.1 **Progress in carrying out project Activities**

Output 1: Participatory resource management plan for East Caicos produced via facilitation incorporating local knowledge of priority cultural, historic and ecological heritage values

1.1 <u>Completed</u> in year 1.

1.2 <u>Completed this reporting period</u>. Induction training completed this reporting period, though on-thejob coaching is ongoing. TCNT staff on Middle Caicos able to effectively support the project as a result.

1.3 <u>Completed this reporting period</u>. MCS, with support of RSPB and TCNT developed a list of stakeholders for CVM filmed interviews, ensuring the provision of a gender-representative range of stakeholders with emphasis on capturing youth perspectives too. See Annex 4 item A20.

1.4 <u>Completed this reporting period</u>. MCS and RSPB with support from TCNT developed interview questionnaire, workshop protocols, and consent forms and used them in the CVM workshops. See Annex 4, items A21, A22 and A23.

1.5 <u>Completed this reporting period</u>. The TCNT Community Engagement Officer, based on South Caicos, supported by RSPB/MCS piloted interview questionnaire with community members in South, North and Middle Caicos, ahead of the stakeholder workshops.

1.6 <u>Completed this reporting period</u>. MCS finalised the list of participants for filming and workshop across 4 inhabited islands and arranged filmed interviews and workshops. Project partners developed a set of target stakeholders, with TCNT providing critical support in engaging potential film interviewees. Emphasis was placed on the finalised participant list being gender-representative while also having a focus on youth participation. See Annex 4 item A24.

1.7 <u>Completed this reporting period</u>. MCS's UKOT Conservation Officer and Social Science Officer visited TCI for 3 weeks in October 2023 to implement CVM filmed interviews. With support of TCNT, the team carried out 23 filmed interviews with 31 participants across Providenciales, North, Middle and South Caicos between 4th - 21st October 2023. The filmed interviews used an interview questionnaire that focused on themes including sense of place, community issues, connection to East Caicos and visions for its future management. Interviews were, on average, just over 60 minutes each. A blog regarding this fieldwork trip was also created for the MCS member magazine. See Annex 4, items A25 and A26.

1.8 <u>Completed this reporting period</u>. RSPB, supported by TCNT engaged a local filmmaker (Romello Williams) to make a film of East Caicos using a drone. This was shown at the community engagement workshops, school talks and prior to boat trips taking students to East Caicos (2.12 and 2.13 below). It will have further uses such as being placed on the proposed website. Link to film is <u>here</u>.

1.9 <u>Completed this reporting period</u>. TCNT, supported by RSPB hosted two Community Engagement Workshops: one on South Caicos and one combined on North and Middle Caicos in May 2023. Knowledgeable community members who had long-term residence on South, Middle or North Caicos and with existing place specific knowledge of East Caicos obtained either through historical or current visits to East Caicos (e.g., fishermen, plant collectors, recreational users) to attend the workshops and results incorporated in 1.10 below. Most community members who had visited East Caicos were male and fishermen. Approximately 14 community members participated in the workshops. The drone film of East Caicos (see 1.8 above) was shown at each workshop, and participatory mapping exercises were conducted to identify the localities and boundaries of places of importance, key ecosystem services and people's relationships with specific places. Semi-structured interviews were conducted with community members who were either unable to attend the interviews, or key people who attended the workshop to follow-up on specific issues more in-depth. Where necessary, individual conversations were held with interviewees at a place and time of their choosing. Eighteen individuals were interviewed. In all a total of 25 community members were engaged (20 males and 5 females).

The workshops and interviews were audio recorded, transcribed verbatim and coded using the qualitative software NVivo software. A thematic content analysis identified key ecosystem services mentioned by community members associated with East Caicos and in-depth narratives the value and importance of places generating rich stories on local knowledge, cultural practices, past and present-day use (evidence in Annex 4). Further work will take place in Year 3 to write up a full report integrating the digitised maps, and in-depth qualitative data.

1.10 <u>Significant progress made this reporting period</u>. RSPB staff (Dr Natasha Constant and Alison Beresford (Senior International Conservation Scientist) have completed both i.) the digitisation of the key ecosystem services generated through the community workshops (1.9 above) and ii.) bringing together the disparate ecological and habitat data from public sources (identified through the desktop and literature search (3.1 below). See Annex 4 item A 9 for summary. Full report will follow later.

Further work will take place in year 3 to i) bring this data together in one place ii.) make this data accessible through strongly visual maps that will form part of the management plan and iii) produce the data in other formats to advocate for the nature-based future for East Caicos.

1.12 <u>Completed this reporting period</u>. MCS transcribed and analysed the filmed interview data (in collaboration with RSPB) between (dates) and produced an analysis summary. CVM interviews were transcribed externally and were returned to MCS for analysis. All interviews were coded in NVivo based on (a) the interview structure and (b) common themes. Interviewees were also classified to ensure the film output was representative of a wide variety of stakeholder groups, genders and ages. To ensure transparency with partners without access to NVivo software, a film narrative that reflected the findings of the coding was produced. A long script was produced based on the coding analysis which was shared both within MCS and to ARK to provide feedback. This was then shortened in a way to ensure that the common themes were represented, and all participants were present in the final film. See Annex 4, items A27 and A28.

1.13 <u>Completed this reporting period</u>. The CVM film output entitled '*East Caicos – Our past, our present, our future*' was created using Premier Pro, with drafts sent to project partners to ensure the project team were happy with the output.

1.14 <u>Completed this reporting period</u>. MCS, with the support of TCNT, arranged and promoted the CVM film screening across North, Middle and South Caicos and Providenciales. Promotion was by flyer either in physical form or electronic. WhatsApp contacts and groups were used primarily with team members making extensive use of their contacts to "snowball" publicity. A decision was made on safety grounds (in the light of recent increased gun violence) to not host open public meetings on Providenciales but to invite stakeholders through an RSVP system. See Annex 4 item A16 for photographs of flyers used to promote the CVM screenings. The screenings were also promoted by social media

1.15 <u>Completed this reporting period</u>. MCS with the support of TCNT and RSPB held six (6) CVM screening workshops (including discussion and feedback) targeting communities across North, Middle and South Caicos and Providenciales between 19th March and 5th April 2024. There were approximately 75 attendees at these three workshops. A bespoke in-person screening of the film was provided to Government Minister (Honourable Josephine Connolly), Permanent Secretary (Honourable Wesley Clerveaux) and the Director of the Fisheries and Marine Resource Management Department (Mrs. Thecla Joseph).</u>

Activities 1.11, 1.16, 1.17 and 1.18 not scheduled for this reporting period.

Output 2: Sustainable, long-term, locally owned and designed small business and naturebased tourism plans developed for East Caicos.

2.1 <u>In progress</u>. Whilst regular contact has been made at a leadership level between representatives of this project and Invest TCI and CED this has not yet been translated into workshops or practical help for potentially relevant business owners.

2.2 <u>In progress</u>. Regular contact has been made at a leadership level between representatives of this project (TCNT's Executive Director) and representatives of Dept. of Culture and Experience TCI. Experience TCI is the new DMMO (Destination Marketing and Management Organisation) that has replaced the Tourist Board during the life of this project. Emphasis is on placing East Caicos at the heart

of any international brand development of TCI. The small business. (TCI Assured Authentication) is still on the agenda but may not happen within the life of this project.

2.4 <u>Significant progress.</u> TCNT together with the Fisherman's Co-op on South Caicos has identified many of those fishermen with the relevant skills set and is engaging them eg through the stakeholder workshops. Some of their views are to be heard in the CVM film (1.13 above) and their knowledge incorporated.

2.6 <u>Completed this reporting period</u>. BirdsCaribbean led a five-day Caribbean Birding Trail (CBT) Interpretive Bird Guide Training Workshop for current and prospective guides from TCI on Providenciales between 23rd and 27th October 2023. Support was provided by the Turks and Caicos National Trust and Department of Environment and Coastal resources (DECR). Twenty-four participants attended including 19 guides from 13 companies interested in moving into providing birdwatching activities. See Annex 4 items A3, A4, A5 and <u>here</u>.

2.7 <u>Completed this reporting period</u>. BirdsCaribbean held a half-day workshop for hoteliers to inform them about how the benefits from birdwatching tourism. The event was hosted by the Ritz Carlton but was unfortunately only attended by 4 attendees from 3 establishments. There are few small providers and no real eco-lodges of the type this training was directed at, perhaps explaining the poor attendance, and demonstrating the challenge in developing this market here. See Annex 4 item A2.

2.12 <u>Significant progress</u>. TCNT utilize Heritage & Discovery Clubs in the secondary schools (private & public) for students to be engaged and join educational activities. Over 180 students were engaged by the Community Engagement Officer on South Caicos at various events and clubs. Of these 42% were male and 58% female. Activities included showing the East Caicos film and quizzes about the island. See Annex 4 item A6 for details.

2.13 <u>Significant progress</u>. Fifty-four (54) people made up of 44 students (60% female, 40% male) plus teachers and assistants visited East Caicos on 6th and 13th October 2023 from South and Middle Caicos respectively. Few if any of the persons involved had visited the island before. The logistics of the visit, particularly from North and Middle Caicos are complex. The visits were a great success, and some students can be heard talking about their experiences in the CVM film.

There has been no significant progress towards Activities 2.3, 2.5, 2.8, 2.9, 2.10 and 2.11 in this period.

Output 3: Ecological, cultural and historic baseline established, and presence of nonnative species determined and used to inform conservation management and community empowerment.

3.1 <u>Significant progress made this reporting period – almost complete</u>. The RSPB's Project Manager carried out a desk-based research and review of existing studies and grey literature, identifying gaps in the data and areas for further survey. Support was provided by SWA and MCS for plant and turtle data respectively, and many other individuals and volunteers. Two species specific surveys were carried out with the logistical help of Salterra Resort and Spa on South Caicos – for Reddish Egrets and American Flamingos to bring data for priority bird species up to date. Full results are in two reports (See Annex 4 items A7 and A8) but in summary East Caicos is globally important for both these species. This had not been known before. Four bird species have been identified as occurring in globally important numbers on East Caicos and all now have up to date population estimates.

This data was used to support the inclusion of East Caicos in the Key Biodiversity Area submission for North, Middle and East Caicos (3.10 below). See Annex 4 items A10 and A11 for the KBA submission and supporting data.

3.7 <u>Significant progress made this reporting period</u>. A total of four turtle nesting and foraging habitat surveys of East Caicos were carried out during this reporting period. This involved assessment of index nesting sites identified in Yr 1 along with key turtle foraging habitats (seagrass beds, reefs) identified as part of the TCI Turtle Project. All encountered turtle nesting and foraging activity was categorised according to the sea turtle nesting protocol, with locations georeferenced too. The TCRF-led live-aboard dive expedition (see Activity 3.9) also documented turtle nesting activity using drone surveillance techniques while conducting their research activities. See Annex 4 item A32.</u>

3.8 <u>Significant progress made this reporting period</u>. See Annex 4 item A33 for a Field Summary Report. All foraging and nesting data collected during this reporting period will be used to provide a final analytical report at the end of the project with recommendations.

3.9 <u>Completed this reporting period</u>. TCRF led a 6 day live-aboard dive expedition off the north coast of East Caicos between July 29th and August 5th 2023, to assess extent of Stony Coral Loss Disease. Benthic data was collected as well as fish biomass data. This was the 3rd expedition to East Caicos since 2018. The original aim was to repeat the data collection every two years (with 2020 being cancelled) but the 2023 thermal bleaching event means that TCRF will be returning annually to assess the loss and/or resilience of the reefs of East Caicos.

This now yearly expedition will help provide a comprehensive picture of the underwater flora and fauna found there. Evidence of her reefs' resilience to disease paints a picture of hope for coral reef management and restoration initiatives. In 2023 17 volunteers participated of which 10 were researchers and 7 were citizen scientists learning and volunteering. There was representation from 3 Darwin grants, 2 Plus and 1 Local (East Caicos, Seabirds, Coral Rubble (Darwin Local) on this research trip and were able to bring in unique genets of some of the rarer stony coral species for bio banking in TCRF's new land-based facility on Providenciales. Results are still pending, and TCRF is returning to East Caicos in July 2024 to assess the impact of 2023's thermal bleaching event. TCRF aim to have results analysed this year. And a full report will be available at the end of Y3.

3.10 <u>Completed this reporting period</u>. RSPB completed a submission for the North, Middle and East Caicos Ramsar Nature Reserve to be recognised as a Key Biodiversity Area (KBA) based on four bird species occurring in the area in globally important numbers. Consultations with government through DECR. The submission was fully aligned and co-ordinated with the outputs of DPLUS164 title. See Annex 4 item A11 for the submission.

Activities 3.2 and 3.3 not scheduled during this reporting period.

Output 4: Awareness and appreciation of the cultural, historic and ecological value of East Caicos is increased amongst communities, TCI citizens, the private sector and government stakeholders leading to strengthened support for protected status for E Caicos.

4.1 Less activity than planned in this reporting period. TCNT has suffered from high staff turnover and staff shortages during this reporting period and has been less able than anticipated to engage with the media (through creating stories and doing interviews). This has been part of the thinking behind contracting a private company (TAG Media) to handle social media outputs (see 4.3 below)

4.3 <u>**Ongoing**</u>. A decision has been made to replace publicising the project through traditional media with engaging the public through tailored social media and a website. This was because the media landscape has changed significantly e.g., the local TV channel PTV no longer functions and sales and use of the other channels are rapidly falling. The activity *"TCNT prepare and release media press releases with TC Weekly News, Sun News, PTV, and TCI E News"* will be replaced through a change request.

4.4 <u>**Ongoing**</u>. The Executive Director of TCNT (Winema Penn-Sanders) has regularly updated Government ministers and departmental colleagues on the project and its progress. The idea of East Caicos as part of a Turks and Caicos World Heritage Site has been established.

4.5 <u>Significant progress made this reporting period</u>. RSPB, with support of TCNT has drawn up the film project brief and appointed BTSW productions to make an East Caicos heritage values film. Filming will start shortly and be completed towards end of 2024. See Annex 4 item A12 for the brief.

Activity 4.2 will not take place and will be the subject of a Change Request to remove it.

Output 5: Strengthened capacity of national project partners, TCI citizens and local communities to effectively manage and protect East Caicos wilderness area

5.1 Completed

Activities 5.2, 5.3, 5.4 and 5.5 not scheduled for this reporting period.

3.2 **Progress towards project Outputs**

Output 1: Participatory resource management plan for East Caicos produced via facilitation incorporating local knowledge of priority cultural, historic and ecological heritage values

Baseline Condition: Aspirations of communities on the islands surrounding East Caicos (South, North, Middle) are unclear and no management plan is in place for the island. Local knowledge of cultural and natural heritage not captured, and areas of cultural significance are not mapped.

Progress towards achievement: <u>Good progress</u> made towards this output in the recording period and the output will be achieved fully by project end. Individuals are eager to participate and engage in the exercises so far. The challenge will be to find individuals willing to participate more deeply in Community Conservation Area governance through participation in a council or committee.

Measurable Indicators:

1.1 Three workshops with relevant local communities and stakeholder groups to carry out participatory GIS mapping, visioning exercises, and focus group discussions, capturing the ecosystem services, heritage values and future aspirations for the management of East Caicos by end Y2.

Two workshops and 18 interviews with knowledgeable community members who couldn't attend the workshops or to follow-up on key issues more in-depth were conducted. A total of 25 people on South, North and Middle Caicos interviewed, and their stories captured, digitised on maps.

1.2 At least 30 filmed Community Voice Method (CVM) stakeholder interviews across four inhabited islands – Providenciales, North, Middle and South Caicos – analysed, with representative gender sampling in Yr2Q1; CVM.

31 stakeholders interviewed through the CVM process. This footage edited and made into a CVM film. Gender sampling showed 58% male (n=18) and 42% female (n=13) made up the sample.

1.3 At least 10 young people equipped with cameras and self-capture views/aspirations towards TCI nature in Yr2 Q1

Ca 10 young people so far have been given this opportunity and there will be further opportunities in Y3.

1.4 Analysis of filmed interviews and self-captured footage, and one Community Voice Method documentary film created and screened across four inhabited islands involving with at least 100 mixed-gender, age and background participants by Yr2 Q3

CVM documentary film produced and shown to approximately 75 people through six film screenings/workshops across four islands (North, Middle and South Caicos and Providenciales) in March and April 2024. Details on gender and age balance captured.

1.5 Creation of digital story maps detailing ecosystem services and heritage values of East Caicos by end of Year 2 to be co-created then shared with communities and stakeholder groups.

Scheduled to be completed by end 2024 (Y3) Darwin Plus Annual Report Template 2024 1.6 Community Voice Method and mapping outputs inform, via face-to-face consultation with at least 30 selected stakeholders across 4 inhabited islands, a final draft community-led and designed management plan for East Caicos by end of project.

CVM film and mapping outputs will be completed by end Sept 2024 (in Y3). Management Plan will then be completed

Output 2: Sustainable, long-term, locally owned and designed small business and naturebased tourism plans developed for East Caicos.

Baseline Condition: Local tour guides from hotels/independent local businesses with natural heritage knowledge of East Caicos and its ecological values are low/non-existent and understanding of knowledge amongst youth not quantified.

Progress towards achievement: <u>Slower progress</u> towards this output than planned. Whilst there has been significant engagement with some local businesses, most do not see this as an opportunity yet and/or do not possess the equipment and skills to access East Caicos. The tourist economy is extremely buoyant, and many operators plan to do more of the same (for which there is significant demand) rather than take risks in developing relatively untried products. Planning in any formal sense (e.g., being able to produce a plan for use in evidencing) is not deeply engrained and business decisions are often more spontaneous and organic and certainly, not necessarily made public. That said, there are several businesses who see opportunities in our vision for East Caicos. It seems likely that this output will be just partially achieved by the end of the project. We will seek a Change Request to reflect the issues faced.

Measurable Indicators:

2.1 By Q3Yr2, number of sustainable tourism-based business development plans (incorporating at least 3 social, economic, and environmental sustainability goals), prepared by Middle and South Caicos community workshop participants increases to 5 from 0 (pre project), with at least 3 plans implemented by end of Yr3

Whilst not scheduled for completion within this reporting period it seems clear that having business plans as evidence is not achievable. This level of planning is not something that businesses (particularly the small, local businesses that we wish to encourage) do here as a matter of course, let alone make public. That said, there is interest from several businesses of various sizes in using East Caicos for the sorts of sustainable nature tourism compatible with the aims of this project. As a measurable indicator we will suggest (through a Change Request) that other evidence such as letters of commitment or filmed interviews should be used.

2.2. By end of Yr2, 24 citizens including 5 fisherfolk trained by Birds Caribbean as TCI assured registration East Caicos heritage focussed guides from baseline of 0, with at least 30 bookings made by end of Yr3

BirdsCaribbean carried out the Caribbean Birding Trail Certified Guide training as planned at the target of 24 citizens has been achieved. However, no-one from the target audience of fishers from South Caicos attended even though we publicised it as well as we could within the community. Two operators who bonefish in the area participated in the training but they were not the target audience. We are looking at an alternative way of encouraging fishers to participate. It appears that the commitment of being away from home for five days may have put people off despite it being clear that travel, accommodation, and subsistence would have been covered by the project.

It currently seems unlikely that the indicator of 30 bookings by the end of year 3 will be achieved. We will seek to amend this indicator through a Change Request. 2.3. 10 hotels and eco-lodges that receive training and materials from project in Yr2, each provide 10 of their guests to the local businesses supported by the project from Yr3

TCNT has not had the resource to produce these materials this year. It is also apparent that effecting change within businesses is harder and takes longer than the indicator allows for. It seems unlikely that this indicator will be fully achieved by the end of the project. This is because, in the context of a very buoyant tourist economy here, they do not necessarily have time to listen, plan and implement the changes suggested.

We will seek to amend the indicator through a Change Request to reflect these issues.

2.4. By end of Yr2, 5 TCI-based tour operators (from baseline of 1) publicly advertise nature based, cultural and historic tours of E Caicos led by 3 of 5 trained guides (baseline = 0) on VisitTCI.com, TCNT and Tourist Boards

This indicator has not been achieved. Whilst at least five tour operators have expressed strong support for the idea of East Caicos being developed as a nature-based heritage site, none are publicly advertising East Caicos tours yet though they will take guests if requested. There has not yet been a link-up between trained guides and the three platforms mentioned. We will continue to encourage links over the course of Y3 but it seems unlikely that this indicator will be achieved by project end. We will seek to amend the indicator through a Change Request to reflect these issues.

2.5. 50 young people (aged 11- 18) attend at least 3 workshops, excursions, or educational opportunities (inter-generational learning exchanges, nature-based activities, and interactions with scientists) with 50% demonstrating an improved knowledge of the ecological, cultural and historic values of East Caicos before end of project.

This measurable indicator has been achieved. 25 students, teachers and helpers from South Caicos and 29 from North and Middle Caicos have been taken to visit East Caicos through the project. Feedback from some of the students was included in the CVM film. Further opportunities are planned in Y3. In addition, five (5) talks given at schools and clubs on South, North and Middle Caicos reaching over 180 students. Quizzes and competitions suggest a good and growing knowledge of East Caicos.

Output 3: Ecological, cultural and historic baseline established, and presence of nonnative species determined and used to inform conservation management and community empowerment.

Baseline Condition: Ecological/cultural knowledge and importance of East Caicos limited/unknown. No formal assessments of non-native/native (and invasive species) available and areas of key habitat and population assessments (i.e. of KBA species) unclear.

Progress towards achievement: Strong progress has been made towards this objective over the reporting period and the output will be completed by the project end.

Measurable Indicators:

3.1 Desk-based gap analysis of available peer-reviewed research, studies and other research (including grey literature) done on East Caicos completed by Q4 Yr1, informing field study plans

The desk top study has been completed and the summary report exists in late draft form (see Annex 4 items A13 and A14). It is a live document and will be updated as new data comes in eg from the Kew Gardens led TIPA (Tropical Important Plant Area) project DPLUS114 and from surveys generated by this study itself (eg under 3.2 below). Two surveys have already been carried out directly in response to gaps identified by this project (see 3.2) and more are being

looked at for feasibility under this project. Discussions with other specialist groups has also taken place to understand how identified gaps can be closed and understanding increased. This includes getting quantitative data on the distribution and abundance of endemic TCI Rock Iguanas which have long been assumed to be extirpated from East Caicos but for which some sightings have been unearthed and the feral cat population which is likely to be the significant limiting factor on the Rock Iguana population.

3.2 Targeted population level assessments of IBA bird trigger species and other priority (globally threatened and endemic) species completed using robust, repeatable sampling methods completed by Q3Yr3. 4 TCNT conservation staff to participate in bird monitoring to build monitoring and data management capacity.

Completed. Two bird species were identified through the analysis (under 3.1) as having significant gaps in knowledge. A survey of Reddish Egrets (Annex 4 item A7) took place in January 2024 and identified East Caicos as globally important for this threatened and declining species. A survey of American Flamingos (Annex 4 item A8) took place in February 2024 and also identified East Caicos as important for this species (though not globally so). IBAs (Important Bird Areas) are now being supplanted/replaced by KBAs (Key Biodiversity Areas). The data collected under 3.2 meets KBA qualifying levels and so has been used to support a submission for KBA designation for East Caicos (see 3.5 below) (Annex 4 item A11 for completed KBA Proposal form).

Three volunteers participated across the two surveys. TCNT staff were unable to participate but there will be further opportunities in Y3.

This project is working closely with DPLUS164 to share logistics and surveys for breeding seabirds on East Caicos.

3.3 Quantification and monitoring of nesting sea turtle populations at 5 index sites around East Caicos, completed by end of Yr1, repeated in Yrs 2 and 3

Significant progress was made through four surveys which strategically sampled key turtle nesting and foraging sites across East Caicos. Yr 2 data will be used to inform final analysis and report in Yr 3.

3.4 Extent of Stony Coral Tissue Loss Disease (SCTLD) mapped and quantified once during Yr2 and once in Yr3 at 8 target sites

Completed. In 2023 the marine survey team from TCRF alongside volunteers and citizen scientists were able to collect data on the presence and prevalence of SCTLD along the northern coast of East Caicos. The aim is to compare this data to baseline data collected in 2018 as a part of the E.U BEST KBA analysis project. East Caicos now represents the most comprehensive data set on pre and post SCTLD benthic composition in the Turks and Caicos Islands. Of the 16 sites surveyed in 2018, the 8 sites with highest percentage of stony coral cover were reassessed in 2021, over a year after the arrival of SCTLD on those reefs. This project allowed us to conduct the same surveys again in 2023 helping bolster the data set. These data are still being analysed but anecdotally have provided a sense of hope for the resilience of coral reefs in areas of little human impact.

A further expedition is planned in July 2024 to again collect data on the benthic composition as well as fish diversity and biomass. We know that SCTLD has spread across every forereef in the Turks and Caicos from West Caicos to East and throughout the Turks Islands as well. We are working to locate and map resilience and areas of hope across the islands. East Caicos has a dominant Colpophyllia natans (CNAT - Boulder Brain Coral) reef, a species heavily affected by SCTLD around Providenciales and West Caicos. The tracking of these densely populated spots clarifies where some of our breeding grounds might be. We were also able to bring in 10 colonies of CNAT to our land-based bio bank in Providenciales for genetic safeguarding. They are still

doing very well, and we are keen to expand our efforts for collection during the Yr3 trip in July 2024. See Annex item A15 for infographic summary.

3.5 Completed updated assessment of East Caicos against KBA criteria, informed by project field survey results, submitted to KBA Secretariat by end of Yr3

Completed. Data collected under 3.2 formed the basis for a submission for most of East Caicos to be included in the North, Middle and East Caicos Key Biodiversity Area (KBA). Submission to the Secretariat is awaiting TCI Government approval but is likely early in Y3 of this project. This submission supports one of the recommendations of DPLUS129 which is to extent statutory protection via the North, Middle and East Caicos Ramsar Site Nature Reserve to those wetland areas of East Caicos that are not included to date.

3.6 Presence and potential impacts of non-native species assessed by end of Yr2

This has not been completed in Y2, but important progress has been made in understanding which species should be prioritised and enquiries made regarding methods of surveying. This will be completed in Y3 of the project. Focus is on the impact of feral cats (Felis catis) on TCI Rock Iguana (Cyclura carinata).

Output 4: Awareness and appreciation of the cultural, historic, and ecological value of East Caicos is increased amongst communities, TCI citizens, the private sector and government stakeholders leading to strengthened support for protected status for East Caicos.

Baseline Condition: Significance of East Caicos in TCI limited. Awareness of cultural, historic and ecological value of East Caicos within TCI unknown but likely low/limited to individuals with specific interest.

Progress towards achievement: Progress has been made towards this objective. The CVM film (1.2 above) has been shown to senior members of Government and we know that Government Ministers and the Premier himself are aware of this project and are discussing possible futures for East Caicos including a submission for it to be a World Heritage Site. Awareness of the alternatives to full development has been increased. Other conversations eg through social media are now being had.

Progress has been limited by lack of capacity in TCNT due to difficulties recruiting and retaining staff. We have worked on solutions to this local capacity issue eg by contracting out social media generation to a private company (though this too has had issues).

The production and showing of the film in Y3 will be significant and we are looking to "close the gap" on some of the targets in Y3. This will be easier when we have the content from the stakeholder workshops to better articulate the community's views.

The Governments Department of Culture and Heritage is very interested in the project and has been invited to participate more deeply in its development.

Measurable Indicators:

1.Six Podcasts and radio interviews "speak your mind TCI" and film reach 75% of registered TCI voters (c.7,732) citizens, by end of project

Progress towards this indicator is slow. Lack of staff resource and capacity at TCNT has prevented the podcast and radio interviews being carried out to date. The East Caicos film has been contracted out and is currently being made, due for completion in January 2025. We are hoping to close the gap on these targets in Y3.

2. East Caicos nominated as Western Hemisphere Shorebird Reserve Network site by end of Yr3.

Data analysis and investigation under 3.1 and 3.2 above show that the site is not suitable for this designation and this indicator will be the subject of a Change Request to remove it from the project.

3. At least two media press releases shared with TCI media outlets per year and at least two articles in TCI news outlets by end of project, plus 12 social media posts per annum, detailing progress of project and community-led efforts to embed protection for East Caicos and create Community Conservation Area

The management of social media has been contracted out to a local private firm (TAG Media) to make up for the lack of staff resource and capacity at TCNT. The East Caicos Wilderness Instagram site is <u>here</u> and the East Caicos Wilderness Facebook site is <u>here</u>. The social media post "target" has been exceeded. We expect to close the gap on these targets during Y3.

4.>2,000 online views of E Caicos video produced, featuring narration by well-known TCI TV personality by end of Yr2

This has not been achieved yet. A contract to a local filmmaker has been issued and the film is about to start production though the film will not necessarily be narrated by a well-known TCI personality.

5.Annual briefing for Senior TCI Government Ministers, Government Officials and Governor on project progress

Achieved. The TCNT's Executive Director is regularly involved in discussions with senior government ministers including the Premier. The relevant Cabinet Minister (Honourable Josephine Connolly) and her Permanent Secretary (Hon Wesley Clerveaux) attended a private screening of the CVM film and a subsequent Q&A session with TCNT's Executive Director and the Project Manager on 27th March 2024.

Output 5: Strengthened capacity of national project partners, TCI citizens and local communities to effectively manage and protect East Caicos wilderness area

Baseline Condition: Capacity to engage project target communities limited and structures to effectively manage/protect East Caicos not in place.

Progress towards achievement: Capacity to engage communities about the project have been significantly increased and are active (eg Community Engagement Officer based on South Caicos and allocation of TCNT staff with relevant skills to this project). Structures to effectively manage East Caicos have not yet been established and are planned for Y3.

Measurable Indicators:

5.1 Partner capacity increased by end of Yr1 through recruitment of a South Caicos-based Community Engagement and Outreach Officer and Heritage Support Officer to TCNT.

Achieved in Y1. Active in Y2. In practical terms, the appointed Heritage Support Officer (Charmony Hislop) has taken over the role formerly carried out by Della Higgs. The latter has been fully involved in the East Caicos project, her skills being far more suited to what the role and project requires.

5.2 Technical assistance from project team to on-island partners and 4 self-appointed leads from within South and Middle Caicos communities enables E Caicos Management plan to meet the IUCN-recognised Community Conservation Area (CCA) Traditional Management Plan standard, by end of project.

Scheduled for Y3

5.3 Community-based East Caicos conservation area governance system in place with equal gender representation, supported by technical assistance from the project team in Y3.

Scheduled for Y3

5.4 Environmental Funders Network bid (EFN) funding bid prepared and submitted in Yr3 to embed local capacity.

Funding bid is scheduled for Yr3. However, we are awaiting confirmation – anticipated by Q2 Yr3, of whether EFN can disburse grants, or whether we will source funds from elsewhere.

3.3 **Progress towards the project Outcome**

Project Outcome: Participatory resource management plan for East Caicos produced via facilitation incorporating local knowledge of priority cultural, historic and ecological heritage values

Progress towards Outcome:

Outcome indicators:

1. East Caicos Community Conservation Area (CCA) registration provides governance framework for its future protection by end of project

The baseline is that there was no discussion or possibility of the outcome happening without this project. By this indicator, considerable progress has been made towards the outcome at this stage of the project.

The registration depends on a group of citizens concerned enough for the future of East Caicos to come together with a mandate to represent their communities by the end of the project. Progress towards this indicator has been made during the reporting period. The stakeholder workshops and CVM film making process has begun to draw out some individuals who might be prepared to provide the local governance necessary to make the CCA successful and detailed discussions are being had as to how the governance of the CCA might be structured eg what the relationship of the Turks and Caicos National Trust to the CCA Council might be.

Whether we will have made sufficient progress on this for East Caicos to be registered as a CCA by the end of the project is not guaranteed. This registration process is, of course, dependent on the outcome of our work consulting with community and stakeholders and it may be that the community does not want this outcome. A that the community do want some sort of outcome consistent with this.

Issues faced include whether there will be sufficient individuals emerging from the local communities to form an effective governance structure and how the local National Trust is able to support the process and the development of these individuals with partner support.

2. Future vision for the conservation of East Caicos underpinned and agreed by the East Caicos community conservation group, by end of project

The baseline is that there was no vision for the conservation of East Caicos at the start of this project. By this indicator, considerable progress has been made towards the outcome at this stage of the project.

As with progress against indicator 1 (above) there is, at this stage (end of Y2) of the project, still a variety of views on the future of East Caicos as expressed by the community and stakeholders. There is a significant consensus that East Caicos cannot and should not be subject to the kind of unplanned development that Providenciales has been subjected to. A consensus within that broad view as to what the future of East Caicos should be, has not yet been developed (and may Darwin Plus Annual Report Template 2024 13 not within the life of this project). Views range from no development at all and/or full protection to a more nuanced spatial approach that allows some low-key nature-based, sustainable development.

It is only at the end of Y2 (the time of writing) that the major consultations and stakeholder workshops are still being carried out. We are confident that there will be a vision at the end of the project that deepens the commitment to the conservation of East Caicos.

3. By end of project, East Caicos heritage values receive elevated support amongst 8 local businesses (5 local hotels and 3 tour operators), as measured by new livelihood opportunities (nature tours led by 5 newly trained guides)

The baseline for this indicator is that at the start of this project was there were no local hotels catering for ECW visits, and only one boat operator doing informal visits. No trained guides were in place to the best of our knowledge.

There is no doubt that the project is succeeding in growing interest in, understanding of and support for a nature-based future for East Caicos. It is unlikely that this indicator will be achieved by the end of the project (as described previously). Effecting change in businesses is harder and more time-consuming than the indicator takes account of and it may be that the indicator of elevated support is changed (via a Change Request) to businesses joining an East Caicos partnership and demonstrating that support through letters.

4. By end of project, the proportion of Turks and Caicos citizens interviewed that are supportive of maintaining East Caicos as a wilderness area, supporting local livelihoods development, increases by 50% from baseline determined in Yr1

Delays to the start of the project due to difficulties in recruitment meant that no baseline was established in Yr1. This indicator will be the subject of a Change Request.

5. The maps of key areas of critical importance for historic, cultural and environmental heritage conservation enable the CCA and other governing bodies to protect these from future development threats by end of Yr2

These maps have either been produced or are in the process of being produced. Work in Y3 will make these more accessible in a strong visual form and combine the different areas of interest in layers so that heritage "hotspots" can be identified.

3.4 Monitoring of assumptions

Assumption 1 Covid19 does not prevent face to face workshops in Middle and South Caicos. *Holds true – no issues in travelling around TCI.*

Assumption 2 Fisherfolk interested in and keen to diversify livelihoods, participate in training. Holds partly true. No fisherfolk from South Caicos attended Bird Guide training on Providenciales. We will need to try a different approach, likely go to South Caicos to attract them to attend.

Assumption 3 Sufficient investment or loans are available to initiate start-up businesses. Holds partly true. Invest TCI have not yet made available any additional loans to initiate start-up within this project scope.

Assumption 4 Stakeholders agree to participate in CVM process including filmed interviews, self-capture camera exercise, participatory workshops, and face-to-face consultations. *Holds true. Stakeholders willing and attended. Good turnout including from target communities.*

Assumption 5 Stakeholder engagement activities (CVM, GIS Mapping) adheres to TCI Covid measures (e.g., social gathering numbers, social distancing etc) to promote safe participation and minimise any disruption caused by ongoing pandemic. *Holds true, Covid-19 restrictions lifted in TCI.*

Assumption 6 International tourism picks up to pre Covid19 levels.

Holds True. Turks & Caicos has an exceptionally fast-growing tourism economy and has made a full recovery (<u>https://today.caricom.org/2022/05/30/tci-on-track-for-full-tourism-recovery-</u> caricom-business/)

Assumption 7 Participants able to agree on small business development opportunity priorities. *This assumption has not been tested yet.*

Assumption 8 Fisherfolk interested in and keen to diversify livelihoods, participate in training. Holds partly true. No fisherfolk from Sth Caicos attended Bird Guide training on Providenciales. We will need to try a different approach, likely go to South Caicos to attract them to attend.

Assumption 9 Tour operators willing to accommodate and optimise East Caicos as part of their offering.

Holds partly true. Tour Operators have been slow to accommodate let alone optimise East Caicos in their offering.

Assumption 10 Young people willing and able to attend event excursions. Holds True. Young people very willing to visit East Caicos

Assumption 11 Field survey timings optimised to determine quantitative assessment of priority globally threatened and IBA trigger species. *Holds true. Surveys carried out at optimal times.*

Assumption 12 Conditions allow sea turtle nesting monitoring; pandemic does not inhibit travel to East Caicos

Holds True. Pandemic not causing any travel issues in TCI.

Assumption 13 Sufficient data generated to enable KBA criteria assessment Communities willing to share local knowledge around plants and wildlife and heritage sites within East Caicos Surveys able to detect presence of non-native species.

Holds true. Minimal effort required to detect invasive species during RSPB/TCNT visit to East Caicos. We expect future surveys will have no issues in detecting the presence of non-native species.

Assumption 14 People tune in sufficient numbers to listen to podcasts and interviews. *Not tested yet as no podcasts or interviews produced.*

Assumption 15 WHSRN approve East Caicos nomination. *This will not be tested. Site now known NOT to be suitable for this nomination.*

Assumption 16 Project runs smoothly and to plan to enable Green List criteria to be met (Good Governance, Effective Management, Sound Design and Planning, successful conservation outcomes).

Mostly holds true. There were some delays in recruitment and adjustments to timelines have been made. This has no impact the project outcome, and a change request was submitted and approved in Dec 2022.

Assumption 17 Press releases appeal to media outlets. *Holds true. One article published locally.*

Assumption 18 Recruitment able to attract sufficient quality candidates from within TCI or wider region.

Holds true. Both recruits are from TCI. Darwin Plus Annual Report Template 2024 **Assumption 19** Community interested and willing to establish a Community Conservation Area for East Caicos.

Holds true. Communities participating in events/presentations provided so far.

4. Project support to environmental and/or climate outcomes in the UKOTs

The eastern portion of the North, Middle & East Caicos Islands Ramsar site covers around 18% of East Caicos; the Ramsar wetlands are contiguous with the rest of the island. The project will deliver against recent Ramsar Resolutions, particularly XIII.15 of the 13th COP to the Ramsar Convention on Wetlands. Parties were encouraged to "...seek mechanisms that allow the conservation and transmission of traditional knowledge of indigenous peoples and local communities including in the sustainable use of natural resources, with scientific advice." (23) This aligns closely with the project goals. Furthermore, Contracting Parties were encouraged "to continue to promote cultural diversity and traditional knowledge systems and practices within wetlands as part of holistic approaches to planning..." (24) matching our proposed approach with the project.

Convention on Biological Diversity (CBD): This project will contribute to the post-2020 framework ambition of '30x30', as it will add a substantial area of high conservation value to TCI's PA network. As TCI already has circa 26% of land protected, and given East Caicos alone makes up 5% of TCI's land area, this project could achieve the 30x30 target for TCI, five years ahead of target.

The project will contribute to UN Sustainable Development Goals (SDGs):

- (1) No poverty, by creating and developing viable and long-term economic opportunities for local communities. Whilst there are no readily available statistics, anecdotal evidence from local partners indicates that the South Caicos community does not receive the same economic benefits as communities of Providenciales. This project seeks to change that.
- (8) Decent work and economic growth, particularly target 8.9 (implement policies to promote sustainable tourism that creates jobs and promotes local culture and products) by developing sensitive eco-tourism opportunities and local businesses selling traditional products.
- (11) Sustainable communities, particularly target 11.4 (strengthen efforts to protect and safeguard the world's cultural and natural heritage) by improving public understanding, appreciation, and willingness to steward the cultural, historic and environmental heritage values
 of
 East
 Caicos.
- (14) Life below water and (15) life on land, by increasing knowledge of island biodiversity to inform effective management and protecting loss of habitat from insensitive development through the creation of a Community Conservation Area.
- CMS Article III: The project's nesting turtle monitoring will contribute to conserving "habitats or species that are of importance in removing the species from danger of extinction". The project will contribute to TCI Government's Vision 2040 policy 'NC3.1 Good ecosystems, marine and aquatic resource management', (role of Protected Areas in the management of ecosystems) and contribute to the 2001 TCI Environment Charter (points 2 [protection of key habitats] 7
- [update baseline data] 9 and 10 [education]). It will also meet Goal 15 of the People's Plan for Empowerment and Inclusive Growth (TCIG Green Paper) to "Protect the Land and her Bounty" ... particularly the 40+ terrestrial habitats identified in the Turks and Caicos Islands, which range from dry forests to wetlands.

 There has been some progress in compiling sea turtle nesting data on East Caicos (see activity 3.7)

The project has a strong commitment to gender and social inclusion. In addition to the following proportions of women in Board and leadership positions, one of the two posts recruited locally for this project is female.

The project is focussed on representing the views of three of the poorest and least developed communities in TCI – those of South, North and Middle Caicos. In this the project is ensuring a voice for those who are socially excluded from the main decision-making locus of Providenciales and the dominance of international capital that advocates unsustainable development. The very method used, that of Community Voice Method (CVM), aims to represent all views but particularly those that are least represented.

All three communities engaged are either rural or fishing and therefore inherently conservative. Ensuring that women are represented has required pro-activity on the project's part. The CVM screening workshops, particularly in Providenciales, were designed to be run over three consecutive days at morning and early afternoon times to overcome barriers that certain demographics face in participating. Out of the 53 attendees who signed attendance sheets across the six workshops, a total of 21 (40%) were female, and this rose to 48% (n=15) with just focusing on the three Providenciales workshops. The community workshops and interviews specifically targeted community members with place specific knowledge of East Caicos obtained

through historical or current visits to the island therefore, of the 25 community members who participated in the workshops and interviews only 5 were women. Although efforts were made to engage women in these conversations the composition of community members with place specific knowledge of East Caicos were primarily restricted to male fishers. That said, across Y2 of the 517 persons considered "engaged" by the project through workshops, talks etc, 60% of those engaged were female. The proportion of females declined with increasing age group. More youths and students engaged were female than elders.

6. Monitoring and evaluation

The three partners meet formally once a year part as review of the previous year and part planning the following year. The last was May 2023 and the next will be in May 2024. In addition to the once-a-year formal project meeting between partners, there are constant other meetings at which partners actively monitor, evaluate and manage the East Caicos Wilderness Project.

The RSPB Project Executive (Charlie Butt) and TCNT's Executive Director and representative on the Project Board Winema Penn meet monthly and the RSPB Project Manager (Simon Busuttil) works out of the TCNT office enabling regular and close contact, communication, and planning. Opportunity was taken in November 2023 when the Project Manager was on his annual visit to the UK for a f2f meeting at MCS HQ in Ross-on-Wye between RSPB and MCS.

Smaller work teams form as and when necessary eg a social science technical team from RSPB, TCNT and RSPB met regularly during late 2023 to develop the methods, questionnaires and consent forms necessary for the community consultation, CVM film production and stakeholder meeting and in the run-up to the stakeholder workshops in TCI a slightly different group of staff from the same three organisations met weekly during 2024 to plan strategy and logistics. The same group carried out a comprehensive review of both the formal and informal outcomes from the CVM film shows, Ministerial meeting and stakeholder workshops which was fed to the Project Board. As per the model *Plan-Do-Review* the response to these findings were incorporated into workplans for Yr3.

The emphasis has been on flexibility, as all three organisations but particularly the National Trust are short on staff resources. This also allows adaptive management.

The Project Implementation Plan (PIP) See Annex 4 item A19 is the primary tool that the three partners use together to track progress against activities and outputs. This live document with a comment column is updated after almost any meeting between partners. This retains focus on the activities, outputs and outcome of the project. The Project Manager "scores" each under the RAG (Red, Amber, Green) system for ease of consideration.

M&E is agreed to be the responsibility of the Project Manager. Financial M&E is via the RSPB's Finance Department (represented by the Senior International Finance Officer, Wendy Cain).

After a "quiet" Y1, the three partners have had a lot more contact (as per above) in Y2. The light touch approach in terms of formal project management and the focus on activities and outcomes has been successful. There are no project failures which arise from not having a different project management and monitoring system. We will continue through Y3 as we support the development of the Community Conservation Area.

7. Lessons learnt

What has worked well?

Close team relations both as individuals within the project and organisationally has been crucial. Time spent together socially, and good communications have built trust.

The light touch project structure has focussed on delivery (rather than reporting) and caught up on many objectives (activities and outputs) after a very slow start due to delays in recruitment.

Clearly allocated activities to partners and the use of a one-stop-shop Project Implementation Plan (PIP) as a simple shared project tool have made monitoring progress and evaluating issues simple.

Having the Project Manager embedded within one organisation in-country has also helped get "under the skin" of issues and shift focus where necessary.

What has not worked so well, and we would do differently in future?

Several of the elements in the project, particularly those under Output 2 can now be regarded as clearly over-optimistic. They depend on actions on the part of the business community and are therefore out of our control. The lead in time for business decisions is much longer than the project allows for. **More rigorous challenge during project development** would have likely identified this issue and allowed us to suggest more achievable targets.

These lessons, particularly the greater rigour during project development have been incorporated into the successful Darwin Strategic bid DPR 12ST.

8. Actions taken in response to previous reviews (if applicable)

After a very slow start and consequent "quiet year 1", the project team felt it premature to submit a Change Request Form until a clearer stronger overall idea of the challenges and issues facing the project. We have deliberately not submitted a Change Request Form during Yr 2 and now feel confident to submit a coherent Change Request which deals with the comments made in response to our Y1 Annual Report. The comments and our suggested response (which will be submitted by Change Request) are below.

9. Risk Management

There are no new risks that have emerged over the past year. That said the impact of three risks on the project has become clearer over Y2. These three risks are:

- 1. Reduced capacity for TCNT due to staff recruitment and retention issues has had a significant impact on Outputs 2 and 4 of the project.
- 2. The re-organisation of TCI's Tourism sector through the replacement of the Tourist Board by a Destination Marketing and Management Organisation (DMMO) has slowed down progress for some activities but, longer term offers greater opportunities as the project is able to influence their overall strategy (TCI's new brand).
- 3. Businesses have been much more difficult to engage than anticipated and the creation of new products using East Caicos in a nature-based way that they can offer has been much slower to emerge.

The project is adapting to these conditions as described in the report.

10. Sustainability and legacy

After a quiet Y1, the project has been very public with community workshops, stakeholder meetings and social media sites on Facebook and Instagram. This high level of engagement will continue during Y3. The creation of an East Caicos website to facilitate the project's profile is under discussion. High level government ministers including the Premier are aware of the project as are District Commissioners and several local MPs who have been engaged 121.

The intended sustainable benefits of the project are very much still valid. Indeed, the general social picture on Providenciales – booming economy, rising populations of tourists and visitors and the associated issues of overburdened services (evidenced by road traffic and restricted water supply), increased crime and illegal migration – is linked by many to the need for our project.

Whilst we are still creating the Community Conservation Area which we hope will confer some degree of restriction on development of East Caicos the concept of East Caicos as a World Heritage Site has been raised from within government itself, stimulated by this project. We see this as ultimately providing the kind of legal and structural framework that will help protect East Caicos. This should be seen as evidence of increased interest in the island and helping us ensure a sustained legacy for it.

This project by itself cannot create a sustained legacy. It starts that process. Further work will be needed. The project partners have already begun discussing this and most importantly, broadening out the project to include other partners.

11. Darwin Plus identity

The Darwin Plus logo has been used extensively across the project's outputs in Y2 as can be seen from the evidence in Annex 4. In particular, the CVM film which has been widely shown, including to senior Government officials and Ministers features the Darwin Plus logo prominently. Other examples include the stakeholder meeting leaflets (Annex 4 item A30) which were widely disseminated via social media and talks such as the one given at the Birds Caribbean training course.

The project has a clear identity although there has been some confusion at senior government levels between this project and DPLUS128, which includes the extension of the statutory Nature Reserve designation over East Caicos as one of its outputs, both being Darwin Plus projects focussing (albeit to different degrees) on East Caicos.

The rapid increase in shootings on Providenciales in late 2023 and early 2024 prompted a review by RSPB, MCS and TCNT of the public meetings proposed for the CVM film screenings on that island. This did not apply outside Providenciales. Discussions involving staff up to and including Director level prompted an adaptation of the project. Meetings were held away from areas where shootings had occurred, at times of lower risk (ie avoiding weekend evenings) and at "neutral" venues. The issue was resolved simply through the standard risk management process.

14. Other comments on progress not covered elsewhere

The design of the project has shifted slightly over the past year. We have found that support for the projects broad aims seems widespread, deep and sincere with many groups e.g., youth. At the same time, the projects goals of involving businesses in using East Caicos are overambitious. Whilst we can move businesses to support our aims, we cannot push them to use East Caicos before they are prepared to do so in terms of marketing, appropriate equipment and skills. The design of the project has therefore shifted to engaging with all communities including businesses building longer term and deeper support and reduced effort into trying to persuade businesses to move more quickly than they are prepared to. This will be reflected in the proposed change request.

The abolition of the Tourist Board and creation of a new organisation *Experience TCI*, a Destination Management and Marketing Organisation has meant that progress on several issues (such as a TCI Assured certification scheme) has slowed as the new organisation gets itself set up. Equally the opportunity is being taken to promote the natural and heritage conservation concepts that underlie our project and the role that East Caicos could play in the future of the TCI brand.
