The Biodiversity Challenge Funds

The Biodiversity Challenge Funds (BCFs) are the collective name for three of the UK Government's international biodiversity and environment grant schemes: the Darwin Initiative (DI), Illegal Wildlife Trade (IWT) Challenge Fund and Darwin Plus (D+).

Funds are allocated through an open and transparent process against clear criteria, with applications scored and recommended for selection by the BCFs expert committee or advisory group.

Darwin Initiative

Established in 1992, the Darwin Initiative awards grants that enable developing countries to conserve their unique biodiversity, reduce multidimensional poverty and address climate change. The technical committee responsible for assessing applications and providing strategic guidance for the fund is called the Darwin Expert Committee. https://www.darwininitiative.org.uk/

IWT Challenge Fund

The IWT Challenge Fund helps the UK government deliver on its commitment to tackling the illegal wildlife trade (IWT). To date, the IWT Challenge Fund has supported 182 projects in over 60 countries to a value of over £63 million and delivers on the UK's IWT Conference Series commitments by supporting projects that tackle IWT. The technical committee responsible for assessing applications, making recommendations and providing strategic guidance for the fund is called the IWT Advisory Group. https://iwt.challengefund.org.uk/

Darwin Plus

The aim of Darwin Plus is to help deliver long-term strategic outcomes for the natural environment in the UK Overseas Territories (UKOTs). The fund helps to meet commitments under UKOT and UK policies, multilateral environment agreements and the SDGs. The technical committee responsible for assessing applications and providing strategic guidance for the fund is called the Darwin Plus Advisory Group. https://darwinplus.org.uk/

What are the BCFs Expert Groups?

Our aim is to ensure our Expert Groups are inclusive, diverse, and global.

This recruitment is for Experts to join one of two groups: the Darwin Expert Committee (DEC) and the Darwin Plus Advisory Group (DPAG). The Illegal Wildlife Trade Challenge Fund Advisory Group (IWTAG) is **not** recruiting for new Experts this year.

Please indicate in the application which of the two groups you are interested in: you can select both if you believe you can meet the criteria.

Each Expert Group is made up of independent experts including academics, practitioners and NGO representatives, along with government officials, all with leadership experience, technical knowledge and experience of biodiversity conservation and/or multidimensional poverty reduction programmes.

We are looking for individuals who, as leaders in their field, are able to contribute at the highest levels and work effectively as part of a group. Successful candidates will offer sound judgment, excellent interpersonal skills, discretion, the ability to assimilate complex information and preferably come with previous experience of reviewing project applications and justifying their assessment in a committee-type forum of peers.

In addition, Experts are expected to champion the Biodiversity Challenge Funds where possible, with members supporting outreach activities to engage stakeholders and further the objectives of the funds, including attending and presenting at Darwin Initiative/Darwin Plus events, including workshops/webinars for potential applicants and projects.

Description of the role

The primary role of each Expert Group is to provide high quality and independent technical specialist advice to the specific fund they support.

Members are expected to:

- assess and score applications against the published criteria, to agreed timelines and standards, to enable Defra to award funding to high-quality projects,
- provide strategic advice, and
- champion the Biodiversity Challenge Funds

We are currently looking for up to 4 people to fill roles across the two funds: indicatively up to 3 for the Darwin Initiative; and 1 for Darwin Plus.

To maintain a breadth of experience in our Expert Groups, we would not expect to appoint more than one member from the same organisation to a single Expert Group except in exceptional circumstances. Please contact us if you are considering applying and someone affiliated with your organisation is already an Expert Group member.

The appointments will commence from 1 June 2025, for a three-year term, reviewed annually.

Representation

We encourage applications from a wide range of backgrounds, including the private sector, academia and professional institutions, non-governmental organisations, independent experts and other stakeholders based in the UK and in countries where projects deliver their impact, i.e. low- and middle-income countries and the UKOTs.

We recognise the challenges that people with (multiple) protected characteristics may experience in their career progression. We want a group of Experts that celebrate and embrace diversity of thought and experience. We are fully committed to being inclusive and ensuring equal opportunities. We hope to attract a range of diverse applicants – particularly people from ethnic minority backgrounds, people with a disability and people with gender diverse identities.

Time Commitment

You should ensure you have sufficient time to meet the expectations of the role. Some Expert Groups require more time commitment than others. An outline of the number of days and indicative timeline for the next round is presented below:

Successful candidates will also be expected to attend an induction event following appointment.

Qualities and experience required

Defra are looking for up to four people who can demonstrate senior leadership in designing, delivering or evaluating programmes in the countries and territories that we operate.

Successful candidates will offer sound judgement, discretion, and the ability to assimilate and analyse complex information. Candidates will preferably be able to demonstrate previous experience of impartially and robustly reviewing project applications and justifying their assessments in a committee-type forum with peers.

Candidates must be able to demonstrate <u>all</u> the following **Essential** criteria:

- 1. **Substantial and significant technical expertise and knowledge** of topics relevant to the objectives of the BCFs.
- 2. Professional experience of successfully delivering project outcomes in a variety of low- and middle-income countries/UKOTs over several years from concept to closure. Supported by core capabilities around finance, safeguarding, multidimensional poverty reduction, gender, social inclusion, monitoring & evaluation (including logical frameworks), communicating, risk management, capability building, and delivering through equitable partnerships.
- 3. Strong track record of working with, applying and reporting to competitive grant funding schemes. Ideally including assessing project applications or the ability to articulate technically robust projects that provide strong value for money, can deliver ambitious outcomes in line with the criteria, and provide positive and constructive feedback to applicants.

Additional, specific requirements for each fund are set out below.

Darwin Expert Committee (DEC)

Specific Criteria

You are expected to demonstrate substantial specialist and/or generalist technical expertise and experience related to specific biomes, conservation actions, poverty reduction approaches and/or specific threats to biodiversity and human wellbeing.

To help maintain DEC's capabilities and capacity, we are particularly interested to receive applications from candidates who can demonstrate expertise in:

- market systems and private sector development
- nature finance and conservation payments
- Influencing policy at a national or regional level

Or knowledge in one or more of the following biodiversity components:

- Production land-use systems (agriculture, pastoralism)
- Plants, fungi or other less represented taxonomic groups
- Freshwater ecosystems (streams, rivers, and lakes)
- Marine ecosystems
- Dryland ecosystems

However, applications from candidates with other expertise are also welcomed.

We strongly encourage applications from candidates from low- and middle-income countries who meet the requirements, as we strengthen the geographic diversity and improve the representation of these countries and their stakeholders in our decision making.

Darwin Plus Advisory Group (DPAG)

Specific Criteria

We are looking for candidates who have a breadth of experience of projects working in or with the UKOTs and can demonstrate a clear understanding of one or more of the DPAG priority areas, listed below:

- Biodiversity: improving and conserving biodiversity, and slowing or reversing biodiversity loss and degradation;
- Climate change resilience: using nature-based solutions to mitigate and/or adapt to the impacts of climate change
- Environmental quality: improving the condition and protection of the natural environment;
- Capability and capacity building: enhancing the capacity within UKOTs, including through community engagement and awareness, to support the natural environment in the short- and long-term.

In addition to the essential criteria outlined above, we are particularly interested to hear from candidates that:

- Have a good understanding of environmental issues and challenges facing the UKOTs or other small islands or territories AND/OR
- Live and work in the UKOTs.

Terms and Conditions of appointment

Further details are available in the <u>Biodiversity Challenge Fund Expert Groups Handbook</u>. You will be expected to abide by the terms in the Handbook if appointed, including operating with the highest standards of honesty, impartiality, integrity and objectivity.

Period of appointment

The initial appointment will be for a three-year term (with annual review points), with the possibility of reappointment for a further term, subject to approval.

The appointment will start from 1 June 2025 with the first application assessments following fairly swiftly depending on fund.

The BCFs are subject to future spending reviews and in the event the programme does not receive funding in a future spending review, all members' terms will be terminated early.

Individuals who are currently or have previously been members of the Expert Committee or Advisory Group are eligible to re-apply for a further term without a break, subject to open competition.

Remuneration and expenses

We will be offering recruited members a stipend of £350 per day plus reimbursement of reasonable (standard class) travel and subsistence costs for attending committee meetings, and internet costs if needed, based on Defra's T&S policy limits.

The Department has due regard to diversity. Expenses may include reimbursement of reasonable additional childcare or other carer costs that occur due to Expert commitments, and the reimbursement of reasonable additional expenses of disabled people.

Location of offices and meetings

For convenience and efficiency, the default Sift meeting method is virtual, but meetings are expected to be periodically (typically annually) held in person with the options to join remotely if necessary. For our annual strategy discussion meetings, members will be greatly encouraged to attend in person, however we will always accommodate remote attendance where necessary. In person meetings are normally held in London, although other locations may be considered.

Where possible, Sift and Strategy meetings will be held on consecutive days to make in-person attendance easier. Members are expected to be available for and participate in all Sift and Strategy Meetings.

A meeting is considered to be a full day (09:00-17:00, UK time zone) unless otherwise specified, please consider this if joining remotely from a different time zone.

How to apply

Appointments to Defra's Biodiversity Challenge Funds Expert Groups are filled through open competition.¹

To apply candidates must complete the application form on Flexi-Grant which seeks the following information:

- 1. Statement of suitability: It is essential that your statement of suitability gives full, but concise, information relevant to the appointment, clearly demonstrating how you meet each of the essential criteria. Please provide specific examples to establish how you meet each of the criteria. You are asked to address the essential criteria (up to 750 words) and the specific criteria for each fund you wish to be considered for (250 words per fund).
- CV: should include education, professional qualifications and employment history, and the names and contact details for two referees. CVs should not exceed two sides of A4 pages.
- 3. Completed Section 2 on Conflicts of Interest, Conduct and Advertising and Section 3 on Diversity Monitoring.

Applications should be submitted through the online application portal Flexi-Grant at https://bcfs.flexigrant.com/. This is the same system that applicants to the Biodiversity Challenge Funds use. All guidance is available via the Flexi-Grant portal, and replicated on the three BCFs websites.

The deadline for receipt of application is 23:59h (UK time) on Monday 3 March 2025.

¹ Appointments to Defra's Biodiversity Challenge Funds Expert Groups are not ministerial appointments regulated by Office for the Commissioner of Public Appointments (OCPA). The posts will, however, be filled through open competition, in line with OCPA guidelines on best practice for making public appointments.

Selection process

Selection Panel

The panel will be selected from officials in the Department for Environment, Food and Rural Affairs (Panel Chair), the Chair of the relevant Expert Group (or delegated member) and the Fund Manager.

Shortlisting

The selection panel will assess candidates based on the written application against the essential and fund specific criteria (pages 9-10 above), as well as consideration of experience and expertise to ensure the overall capability and capacity of each Expert Group to assess and advise on the breadth of areas covered by the Biodiversity Challenge Funds.

Candidates may be invited for interview, or appointed on the basis of the evidence supplied in the application. It is therefore essential for your application to give full, but concise, information/evidence/examples relevant to the appointment.

Disability

We guarantee to consider anyone with a disability whose application meets the minimum criteria for the post. By 'minimum criteria' we mean that you must provide a full application with evidence which demonstrates that you generally meet the level of competence required for each criterion, as well as meeting any of the qualifications, skills or experience defined as essential.

Defra are committed to the employment and career development of disabled people.

More information about Disability Confident Leaders is available by clicking the logo on the cover page. We have a duty to make reasonable changes to processes where possible to ensure that disabled people are not disadvantaged.

Interviews

Interviews are likely to take place at the end of April 2025 and will take place via MS Teams. Further details will be provided at the time.

Reserve List

A reserve list may be agreed for a period of 12 months from which further appointments can be made to Biodiversity Challenge Fund Expert Groups, or OCEAN Expert Committee².

Ineligibility criteria

You cannot be considered, or will cease to be a member, if:

- you occupy a paid party-political post or hold a particularly sensitive or high role in a political party;
- you become bankrupt or make an arrangement with creditors;
- your estate has been sequestrated in Scotland or you enter into a debt arrangement programme under Part 1 of the Debt Arrangement and Attachment (Scotland) Act 2002 (asp 17) as the debtor or have, under Scots law, granted a trust deed for creditors;
- you are disqualified from acting as a company director under the Company Directors Disqualification Act 1986, or equivalent in any country;
- you have been convicted of a criminal offence anywhere, the conviction not being spent for the purposes of the Rehabilitation of Offenders Act 1974 (c. 53), or equivalent;
- you become subject to a debt relief order or a bankruptcy restrictions order or equivalent;
- you fail to declare all relevant conflicts of interest.

How we will handle your application

You will receive an automatic confirmation of receipt of your application on submission through Flexi-Grant.

The proposed short-listing will take place week commencing 17 March 2025.

Candidates will then be notified by the week commencing 7 April 2025 by email through Flexi-Grant, whether or not they have been shortlisted.

References may be taken up if candidates are shortlisted.

² The OCEAN Grants Programme is another competitive UK government grants scheme, supporting innovative proposals from local coastal communities that aim to deliver marine protection and reduce poverty worldwide.

The interviews, if required, will take place in late April 2025.

Shortlisted applicants will be informed of the outcome by mid-May 2025.

The successful candidates will be expected to attend an induction event in late may/early June 2025 and be available for reviewing applications according to the indicative timings indicated above.
